

THE WHITE LAW FIRM GETS RESULTS.

- The White Law Firm successfully prepared and tried a wife's high-conflict divorce, involving several health-care related businesses owned by the couple and a marital estate with a multi-million gross value. The White Law Firm obtained a favorable judgment on child custody, child support, and the division of the marital assets and debts. The White Law Firm also obtained a money judgment against a new business started during the divorce by the husband, and against the husband individually, the husband's mother and the woman alleged to be the husband's girlfriend.
- The White Law Firm successfully defended a man sued by his ex-wife's boyfriend for defamation. The firm's client had made a report to law enforcement that the ex-wife's boyfriend was sexually abusing his daughter. In a result reported nationally, The White Law Firm was able to obtain a summary judgment in favor of the firm's client, and the case was resolved without the need for trial.
- The White Law Firm, representing the wife, obtained an order sending her husband to jail for contempt for his failure to produce documents and other information requested during the preparation of the case for trial, and for his failure to pay previously ordered monetary sanctions to the wife.
- The White Law Firm represented a husband in a case involving a multi-million dollar marital estate, comprised largely of real estate. The case, which saw the production of hundreds of thousands of pages of documents, was concluded in mediation, for an amount less than the husband previously had offered the wife on his own.
- The White Law Firm obtained a "take nothing" judgment in favor of a client sued by two different creditors claiming that the client owed the creditors a total amount in excess of \$100,000.00.
- The White Law Firm, acting *pro bono publico*, defended an individual sued on a credit card account by an assignee of the original company. Because The White Law Firm had prepared the case vigorously, the creditor dropped its case just before trial.
- The White Law Firm obtained a protective order, spousal support and attorney's fees on behalf of a wife in a common law marriage relationship. The case, still ongoing, is a high-conflict divorce and involves several million dollars in marital assets.
